



OUICK LINK TO WEB HELP FILES

- 1. Read and Compare everything. The mysteries are story based, so check for hidden clues. Take notes if you must, you never know what small detail might be important. Look for pieces of evidence that might relate to each other, or something that suggests those items might fit together somehow. Keep your eyes open.
- 2. Solve all the puzzle. Each puzzle or clue gives important information to solve the case. If the clues are sectioned in envelopes, try and read and solve what you can before going on to the next.
- 3. Most clues or locations are QR Code based. You will need a scanner to open files and progress through the story line. Most of the QR codes in game are password protected and all the answers or keys are hidden in the clues and files.




while bedrooms have lush gray carpet. The room numbers are labeled B for basement, M for main floor, and U for upper floor. DON'T FORGET TO
