You will need a QR Code scanner, Internet access, Scissors, and paper and pen to take notes.

1. Read and Compare everything. The mysteries are story based, so check for hidden clues everywhere. Take notes as you never know what small detail might be important. Look for pieces of evidence that might relate to another (matching symbols or words) that might suggest they fit together. Keep your eyes open.
2. Solve all the puzzles. Each puzzle or clue gives important information to solve the case. If the clues are sectioned in envelopes, try and read and solve everything you can before moving on. Most will have a prompt telling you to move on to the next part or envelope.
3. Some clues and locations are QR Code based. You will need a scanner to open files and progress through the story line. Most QR Codes in the games are password protected and all of the answers or keys are hidden in the story, clues, and files.

Free QR Code readers are easily available and free through an App Store. Newer phones have them built into the camera function. Simply, open your camera and hold it over code, this should prompt a link to pop up, which you can then click to open.


We need you to follow up on the names printed in the paper. As of now, everyone is a suspect, person of interest, or possible victim.

A letter to the editor has sparked outrage, fear, and anger among law enforcement and citizens of Demersville. A Recent homicide in the area has now been claimed by a mysterious killer dubbing themselves, "Dante," who is more than ready to cleanse the town of sinners.

**Statement**

Kacy and I decided to go out for drinks. Actually I talked Kacy into going out, as she had just broken up with her boyfriend, Markus Reed. She needed to let loose a little bit. We only had a couple of drinks when Markus came in to the bar. He tried to buy us a round of drinks, but the bartender told him to leave. Kacy said that she thought he was stalking her so we decided to leave a little while after. When we were leaving I realized I had lost my house keys, so I grabbed a box of matchsticks and we went out to the parking lot. Then we decided to take a walk down to the river instead of going home.

Thats when we came across Rick Mathers. He started yelling and screaming at us. We tried to run away but were separated. I heard Kacy scream "Don't!" followed by splashing sounds. I think that crazy guy Rick pushed her in!

Stella Hanson has not been interviewed prior to the newspapers print deadline. We have decided instead to release her witness statement from the Kacy Fairchild case.

If anyone was at the Purgatory Bar the night Kacy died, Police are asking for witnesses to come forward if they remember anything that could be important.



## Statement

Markus and I had been dating for several weeks. When I found out he had a serious girlfriend, I broke it off immediately. Markus was just a fling and I wouldn't want to come between a "relationship." That's not my style, although I respect people in committed relationships, I am not the type to get myself into one.

Detective Murphy has made it clear, that any information about the above person of interest needs to go directly through him.



The Fairchild's, have once again been brought into the spotlight after tragedy. On the morning of February 2<sup>nd</sup>, Olivia Fairchild, discovered the body of her husband, Richard Fairchild, shot dead in his office. No witnesses to the crime have come forward at this time. "I didn't hear a thing that morning, as his office is located on the east wing of our house. I just walked in to see if he wanted to go to lunch and found him," Olivia, stated wiping tears from her eyes. "Then I found that rretched card and knew he hadn't done himself in."

"Now we are dealing with his loss and the loss of Kacy all over again. Not only that, but I have had to take extra security measures and lock down the house. Only the maid is allowed in right now," said Mrs. Fairchild.

Police are reopening the drowning case of Kacy Fairchild in hopes of determining a final cause of death. "If, Kacy was murdered, we are going to find the killer. We are pulling in resources from nearby towns and have also contacted the FBI, along with Blackburn Investigation," stated Murphy.

Demersville Daily, is also printing the details on the remaining persons of interest that had appeared in the prior investigation reports relating to, Kacy Fairchild's death. All suspects at that time were cleared when Kacy's death was announced as accidental.





Mary Kline, was never suspected in Kacy's drowning. She canceled plans to join the two girls as she had a theology test the following morning. Demersville daily was unable to interview Ms. Kline before our printing deadline. We reached out over the phone, but Mary declined to speak citing being overworked at the coffee house.



Rick Mathers, is a homeless man that usually can be found camping near the river. The earlier police reports cleared Mathers of any wrong doing when Kacy's death was ruled an accident. The police have been unable to locate Mathers.



Elena Boyd, was the bartender at, Purgatory, the night in question. Elena, declined to give a statement to the paper, but Detective Murphy stated that they "are looking into that night five years ago, and questioning if Elena had served the girls too many drinks that night. An experienced bartender knows when to cut off the alcohol"



Jack Stewart a local high profile attorney has recently come under fire. Mr. Stewart is Markus Reed's attorney then and now.





